Nonprofit Organizations receive a **25% discount** on the standard **Commercial** rental rates. All rental fees and charges assessed, including staffing requirements must be paid in advance.

ADDITIONAL FEES:

The User will be assessed an additional **\$150/Hour Fee** (\$200 for commercial) for performance days in which the User's occupancy exceeds eight (8) hours.

** Plus **\$.50** per ticket printed for nonprofit users OR **\$1.25** per ticket printed for commercial users. 3.215% of credit card sales, or current market rate, **whichever is higher**.
Set-up fee if box office is to process individual season ticket orders is **\$100** per # of shows in series.

CREW RATE INFORMATION

EFFECTIVE **07/01/2011**

STANDARD HOURLY RATES:

The hourly rate for stagehands is \$26.00/Hour. This rate includes:

Electricians
Light Board Operators
Deck Hands

Wardrobe
Followspot Operators
Audio Technicians

- A minimum one (1) hour surcharge will be assessed to cover the crew's advance time.

CONDITIONS:

- Minimum Load in, Load out or Performance call is four (4) hours.
- Minimum call back after a one (1) hour break is two (2) hours.
- Mandatory hour meal break is required after five (5) hours of work. If a meal break is not given, the bill rate will be increased to 150% of regular rate.
- Overtime will be billed at 150% of regular rate after eight (8) hours of work per day.
- All time is figured on full hours.
- A 24-hour prior notice is required for all job cancellations, otherwise a fee (equal to the four hour minimum) will be charged.

RATES FOR OTHER SERVICES:

- Rate for *Custodial Personnel* is \$16.00/hour, or current market rate per person.
- Rate for *Security Personnel* is \$19.00/hour, or current market rate per person.
- Rate for *Fire Watch* is \$40/hour, plus a 10% administration fee.
- Rate for *Police Services* is \$39/hour, or current market rate, 3 hour minimum.

HOLIDAY RATES:

A *holiday rate of 150%* is charged when any person works at any time on the following holidays:

New Year's Eve, New Year's Day, Martin Luther King Day, Easter Day, Memorial Day, Independence Day, Labor Day, Veteran's Day, Thanksgiving Day, Thanksgiving Friday, Christmas Eve and Christmas Day.
